

#### 2025-26 Iowa FBLA Calls for Board of Directors Applications

lowa FBLA is seeking applications to serve on the Iowa FBLA Board of Directors. Members of the Board work together to set a strategic direction for the association and ensure that resources are aligned with our mission to inspire and prepare students to become community-minded business leaders in a global society through relevant career preparation and leadership experiences.

## For the 2025–2028 term, we are seeking candidates in the following categories:

**FBLA Collegiate Local Adviser (1 seat):** An individual who is either a faculty member teaching a business and/or business-related class or school staff member and has responsibility for an Iowa FBLA Collegiate chapter. Example: community college adviser, vocational technical center adviser, junior college adviser, a private college adviser, a four-year college/university adviser, or school staff member.

**FBLA High School Local Adviser (1 seat):** An individual currently employed as a secondary educator, who teaches a business or business-related course, and serves as an active Iowa FBLA High School local adviser. Example: junior high school adviser, high school adviser, district or regional adviser, adviser of a private-parochial school.

At-Large: FBLA Collegiate Local Adviser, FBLA High School Local Adviser, or Business/Industry Representative (1 seat): An individual who currently meets the FBLA Collegiate or FBLA High School Local Adviser qualifications above. Business/Industry Representative is a person currently employed in a management-level position of a business or industry, who shows an interest in students and understands the value of student organizations to educational programs.

In your role as an adviser, we hope you will consider applying for the adviser position. Additionally, we ask that you share this announcement with your colleagues and your own network of qualified business supporters, former businesspersons of the year, judges, and alumni who may bring unique expertise to the business/industry representative opportunity.

lowa FBLA believes that diversity of thought, experience, and background is essential in providing a well-rounded experience for its volunteer leadership, professional staff, and student members. In that spirit, we ask that you encourage FBLA local chapter advisers



and business professionals with diverse life experiences, heritages, backgrounds, and viewpoints to apply for these positions.
